

Quantitative disclosure of remuneration to Material Risk Takers 2025

Danica and Danske Bank Group have established a procedure for identifying staff with material impact on Danica's risk profile. Designation of Material Risk Takers (MRT) is based on relevant EU and local regulation. As of 31st December 2025, the number of identified individuals in Danica totalled 21 MRTs (2024: 24 MRTs). The remuneration awarded for Material Risk Takers in Danica in 2025 is detailed in the below tables in accordance with the disclosure requirements outlined in BEK nr 676 of 04/06/2025.
